You are hereby notified of the existence of violation(s) of the Ross Township Code of Ordinances Chapter 5 and or Chapter 27 , as the result of an inspection on 2/23/2016 .

Comment Property owner must move the parking stops immediately parallel to Babcock Blvd. back so as to provide the required visibility for traffic from Cold Spring Drive.

1005 **TRAFFIC VISIBILITY ACROSS CORNERS.** In all districts, no structure, fence, planting or other obstruction shall be maintained between a plane 2 1/2 feet above curb level and a plane 10 feet above curb level. This shall be maintained in order to provide traffic visibility across the corner within that part of the required yard which is within a clear site triangle. The clear site triangle shall be measured from the center line of the cartway 75 feet from the intersecting center lines of the cartway intersections. When one or both streets, which form the intersection, are classified as collector roads or arterial roads, the sight triangle shall be measured 100 feet from the intersecting centerlines of the cartway intersection.


