

ORDINANCE NO. 1300

AN ORDINANCE OF THE TOWNSHIP OF ROSS, ALLEGHENY COUNTY, PENNSYLVANIA, SIGNIFYING THE DESIRE AND INTENTION OF THE TOWNSHIP OF ROSS TO JOIN WITH THE BOROUGH OF WEST VIEW, ALLEGHENY COUNTY, PENNSYLVANIA, TO ORGANIZE A JOINT AUTHORITY PURSUANT TO THE PROVISIONS OF THE "MUNICIPALITY AUTHORITIES ACT OF 1945", THE ACT OF 1945, MAY 2nd, P.L. 382, SECTION 1 et seq., TOGETHER WITH ALL SUPPLEMENTS AND AMENDMENTS THERETO, FOR THE PURPOSE OF PROVIDING AMBULANCE EQUIPMENT AND FACILITIES, AND FURNISHING AMBULANCE SERVICE AND EMERGENCY MEDICAL SERVICES TO THE CITIZENS AND RESIDENTS OF THE TOWNSHIP OF ROSS AND THE BOROUGH OF WEST VIEW AND FOR THE PURPOSE OF EXERCISING AND ENJOYING ANY AND ALL OF THE POWERS CONFERRED BY SAID ACT AND THE SUPPLEMENTS AND AMENDMENTS THERETO; SETTING FORTH, IN FULL, THE PROPOSED ARTICLES OF INCORPORATION OF SAID AUTHORITY AND OTHER MATTERS PERTAINING TO THE INCORPORATION AND ESTABLISHMENT THEREOF; REPEALING ORDINANCE NO. 1285 OF THE TOWNSHIP OF ROSS WHICH HAS DULY ENACTED INTO LAW ON JUNE 20, 1977.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Ross, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by and with the authority of the same, as follows:

SECTION I. Public Necessity

The Board of Commissioners of the Township of Ross finds and therefore declares that it is necessary that an adequate public ambulance service be established, that emergency medical services and rescue and lifesaving services be established and operated, to promote the health, comfort, convenience and general welfare of the citizens and residents of the Township of Ross and of individuals who are stricken with illness or accidents and injuries while within the boundaries of the Township of Ross; and that such services can be most efficiently and economically furnished by means of an inter-community municipal authority jointly sponsored by the Township of Ross and the Borough of West View and incorporated under the applicable laws of the Commonwealth of Pennsylvania for the express purpose of supplying such service to all citizens and residents of said municipalities and to other persons within the borders of said municipalities.

SECTION II. Joint Authority

It is therefore the joint desire and intention of the Township of Ross and the Borough of West View, municipal corporations situate in the County of Allegheny and the Commonwealth of Pennsylvania, to organize an Authority under and pursuant to the provisions of the "Municipality Authorities Act of 1945", the Act of 1945, May 2nd, P.L. 382, Section 1, et seq., together with all the supplements and amendments therefo, for the purposes of exercising and enjoying all of the powers conferred by said Act, its supplements and amendments.

SECTION III. Name of Authority

The name of the proposed Authority shall be:

"ROSS-WEST VIEW EMERGENCY MEDICAL SERVICE AUTHORITY"

SECTION IV. Articles of Incorporation.

The proposed Articles of Incorporation are as follows:

## JOINT MUNICIPAL AUTHORITY

ARTICLES OF INCORPORATION  
TO THE  
SECRETARY OF THE COMMONWEALTH  
OF PENNSYLVANIA

In compliance with the Municipality Authorities Act of 1945, its supplements and amendments, the Township of Ross and the Borough of West View, municipal corporations situate in the County of Allegheny and Commonwealth of Pennsylvania, pursuant to identical Ordinances duly adopted by the governing bodies of such municipalities, hereby signify their joint desire and intention to form an Authority under said Act and do hereby certify as follows:

1. The name of the Authority shall be: "Ross-West View Emergency Medical Service Authority".

2. That this Authority is formed under and pursuant to the provisions of the Municipality Authorities Act of 1945, its supplements and amendments.

3. That no other Authority or joint Authority organized under the Municipality Authorities Act, its supplements and amendments, or under the Act approved June 28, 1935, P.L. 463, as amended, is in existence in or for the incorporating municipalities named herein, except as follows:

(1) The Municipal Authority of the Borough of West View organized by the Borough of West View, County of Allegheny, Commonwealth of Pennsylvania, under and pursuant to the Municipality Authorities Act of 1945, its supplements and amendments, for the purpose of exercising and enjoying any and all powers conferred by said Act.

(2) Ross Township Authority organized by the Township of Ross, Allegheny County, Pennsylvania, pursuant to the Municipality Authorities Act of 1935, approved June 28, 1935, P.L. 463, as amended, for the purposes of exercising and enjoying any and all the powers conferred by said Act

4. The purpose of the Authority is to provide ambulance equipment and facilities, the furnishing of ambulance service and emergency medical services to the citizens and residents of the Township of Ross and the Borough of West View, Allegheny County, Pennsylvania, and to those individuals within the boundaries of the Township of Ross and Borough of West View who are injured or ill.

The Board of the Authority to be formed pursuant to these Articles, shall consist of fifteen (15) members, each of whom, except for those who shall be members of the first Board of the Authority, shall be appointed for terms of five (5) years each. No Board member shall be a paid employee of the Authority. The members of the Board of the Authority shall be apportioned among the several municipalities as follows:



SECTION VI. Compensation, Board Members.

Until such time as the incorporating municipalities shall otherwise provide by Resolution, the members of the Board of the Authority shall receive no compensation for their services as Board members.

SECTION VII. Execution of Articles of Incorporation

The Articles of Incorporation of the proposed Authority, in substantially the same form as set forth in Section IV of this Ordinance, shall be executed on behalf of the Township of Ross by the President of its Board of Commissioners and under its municipal seal, attested by the Township Secretary, and such officers are hereby authorized, empowered and directed to do all things necessary and appropriate to effect and establish the said Authority, in conformity with the aforesaid Municipality Authorities Act of 1945, its supplements and amendments.

SECTION VIII. Effective Date

This Ordinance shall become effective immediately upon final passage and approval.


SECTION IX. Repealer
